The property forms part of the Northgate Retail Centre within Heckmondwike Town Centre, close to the High Street and adjacent to the Bus Interchange. The scheme consists of 10 retail units, a drive-thru McDonalds and a Lidl Supermarket. The property itself fronts Northgate forming a large parade with neighbouring users including Card Factory and Kirkwood Hospice Charity Shop.
